3. BOD's Supervision of the Board of General Directors

Based on the Resolution of the General Meeting of Shareholders and within its authority, the BOD approved and assigned the company's Board of General Directors to implement. The BOD's evaluation of the company's Board of General Directors focused on the following:

3.1. Monitoring of organizational structure

The company maintains the implementation of the company's organizational model in accordance with the Enterprise Law and the company's Charter.

The company identifies the supervision of the organizational structure as an important task in the BOD's supervision of the company's Board of General Directors, directly related to the organizational structure, operational activities, and efficiency of the company. Given the specific nature of the company's business operations, at the request of the company's Board of General Directors, the BOD approves the company's organizational system, assigns responsibilities to the company's General Director, Deputy General Directors, directors, deputy directors of enterprises, heads, and deputy heads of company departments and boards based on maximizing the capacity, intellect, and responsibility of leading individuals in performing tasks, enhancing smooth coordination and mutual support in the process of performing their duties and responsibilities.

3.2. Production and Business Monitoring

Regularly inspect and evaluate the company's monthly and quarterly production and business results. In addition, the Chairman of the BOD and the company's Board of General Directors, along with heads and deputy heads of company departments, participate in regular meetings twice a month to evaluate and monitor the implementation of production and business tasks and specialized tasks of company departments and boards and grassroots units, and at the same time resolve difficulties arising in the company's operations; identify subjective and objective factors to promptly take appropriate remedial measures.

The Board of Directors, especially the Chairman of the BOD, always directly directs each department, board, and enterprise, thereby promptly resolving difficulties arising in the company's operations. During the year, the company developed specific work programs with affiliated units with a plan to work regularly twice a year and organize review meetings and thematic briefings to assess the implementation of production and business tasks to promptly propose solutions and measures to promote effective production and business activities.

Monitoring results demonstrate the Board of Directors' effective implementation of solutions in production and business activities, promptly addressing challenges and fostering positive outcomes.

In 2024, the Company effectively implemented key tasks, including enforcing customer pricing for water and electricity usage according to regulations, controlling electricity purchase costs, and monitoring water and electricity management for efficient operation and cost savings in water production, resulting in high business growth (pre-tax profit increased by 22.95% compared to the annual plan).

3.3. Other Monitoring Activities

- Monitoring of Implementation and Operations: The Chairman of the Board and the General Director assigned tasks to departments, company boards, and factories, organizing timely meetings with relevant parties to address emerging issues within their authority and promptly seeking guidance from the Board of Directors on major operational matters.

- Fulfillment of state budget obligations and timely payment of employee salaries according to regulations.

- Maintaining unity and consensus throughout the Company: no internal conflicts within the Company.

In recent years, the Board of Directors has diligently performed its supervisory duties in accordance with the Company Charter and Internal Regulations on Corporate Governance, as prescribed by law, maximizing benefits for the Company and shareholders. Through monitoring, the Board of Directors assesses that the company's Board of Directors has managed production and business activities with great effort and achieved encouraging results. In the course of operations, the company's Board of Directors has strictly complied with legal regulations, the Charter, and the Company's Internal Governance Regulations.

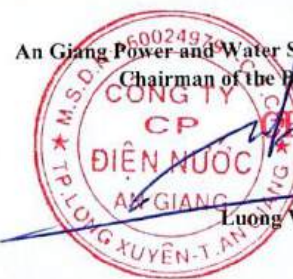
