3. Supervising Board of Directors, Board of Management and shareholders by Board of Supervisors:

- Activities of the Board of Directors (BOD)

+ The BOD directs the implementation of the 2024 business plan approved by the Annual General Meeting of Shareholders (AGM).

+ The BOD issues resolutions/decisions related to production and business activities, personnel organization, labor salary, internal audit, branding, provisioning, AGM organization plans, AGM documents, etc., according to the regulations in the Charter of PV GAS LPG.

+ The BOD effectively directs, supervises, and supports the Management Board and functional departments, units of PV GAS LPG in production and business activities.

+ The BOD directs the restructuring of PV GAS LPG.

- Activities of the Management Board

+ The Management Board implements and directs the functional departments and affiliated units to seriously execute the BOD's resolutions/decisions, overcoming difficulties with stringent measures to achieve the business plan.

+ The Management Board manages and directs production and business activities according to the delegation between the BOD and the Management Board.

+ The Management Board strengthens management, evaluates and categorizes, and takes measures to recover and handle debts, inventory, and idle assets to minimize risks, limiting capital occupation affecting capital balance and cash flow for production and business activities.

+ The Management Board regularly reviews investment projects to ensure safe, quality project implementation according to the approved schedule and the company's actual needs and situation.

+ The Management Board seriously implements the recommendations in the State Audit's report.

+ The Management Board carries out the restructuring of PV GAS LPG.

+ The Management Board regularly works with units to promptly correct business operations according to the general orientation, addressing difficulties in business and investment activities of the affiliated units.

+ Salary and policy regimes: implementing salary payments and policy regimes in accordance with current regulations and rules.

+ Coordination between the Supervisory Board and the activities of the BOD, the Management Board, and other management staff:

The Supervisory Board has close and regular coordination with the BOD and the Management Board of PV GAS LPG in carrying out tasks assigned by the AGM. The Supervisory Board receives support from the BOD and the Management Board in fulfilling its duties, such as the provision of complete information and documents, and the appointment of staff to work with the Supervisory Board upon request. The Supervisory Board's inspection and control summary reports are sent to the BOD and the Management Board.

4. Other activities of the Board of Supervisors:

- The implementation of the 2024 Annual General Meeting of Shareholders (AGM) resolutions.

- Checking and monitoring the implementation of the business plan and the deployment of production and business tasks for 2024 as approved by Vietnam Gas Corporation.

- Monitoring compliance with the company's internal management regulations and procedures.

- Reviewing and evaluating the effectiveness of the internal audit system, identifying and managing risks to provide early warnings and help minimize losses during the company's business operations.

- Inspecting and monitoring capital management and usage; debt management; and the company's procurement and tendering activities.

- Appraising the audited financial statements for 2023, the quarterly financial reports, and the reviewed financial statements for 2024. The company's financial statements are prepared in accordance with the Ministry of Finance regulations and reflect the actual business situation of the entity.

- Evaluating investment performance in other enterprises through company reports to control the operational status of investee units and improve capital efficiency.

- Reviewing contracts and transactions with related parties under the approval authority of the BOD or the AGM, and providing recommendations on contracts and transactions that need BOD or AGM approval.

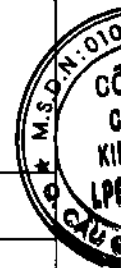
