In the first quarter of 2025, the total sales revenue of the entire group reached 57.31 billion VND, an increase of 156.6% compared to the same period last year. Of which, the sales revenue at the Company was 57.257 billion VND, accounting for 99.91% of the entire group. The after-tax profit at the Company reached 2.621 billion VND, an increase of 482.0% compared to the same period last year, accounting for 118.43% of the entire group; The



consolidated after-tax profit reached 2.213 billion VND, an increase of 2553.1% compared to the same period last year. Of which, the after-tax profit of the Company's shareholders was 2.293 billion VND, an increase of 1427.9% compared to the same period last year.

The reason for the difference: Company has completed the acceptance and payment for the completed volume of the Cam Khe Central Park project.

The above are the main reasons for the difference in revenue and profit compared to the same period last year in the Company's business results.
