

**REPORT ON SHAREHOLDER ELIGIBILITY VERIFICATION**  
**AT THE ANNUAL GENERAL SHAREHOLDERS' MEETING 2025**  
(2nd Meeting held on July 14, 2025)

Today, July 14, 2025, at the Hall on the 24th Floor - Nghe An Petroleum Building, No. 7 Quang Trung Street, Thanh Vinh Ward, Nghe An Province; As assigned by the Organizing Committee of the General Meeting/Company's Board of Directors, the Shareholder Eligibility Verification Committee attending the General Meeting includes:

After verifying the eligibility of shareholders registered to attend the General Meeting and cross-referencing the shareholder list, the Verification Committee respectfully reports to the General Meeting as follows:

- a) The total number of shareholders (including individual shareholders and institutional shareholders) eligible to attend the General Meeting, according to the shareholder list closed on June 16, 2025, is 602 shareholders, who own 15,000,000 common shares (voting shares).
- b) The number of shareholders attending in person or through valid authorized representatives at today's General Meeting is 2 shareholders. These shareholders represent 2,502,860 shares, accounting for 16.69% of the total voting shares.
- c) With the above results, based on the provisions of Law on Enterprises No. 59/2020/QH14 passed by the National Assembly on June 17, 2020, the Shareholder Eligibility Verification Committee announces:
  - The shareholders attending in person or through valid authorized representatives at this General Meeting own 16.69% of the total common voting shares of the Corporation, therefore the second General Shareholders' Meeting does not meet the conditions to proceed.

This report on shareholder eligibility verification was prepared at 09:00 AM on July 14, 2025, and has been publicly read before the General Meeting.

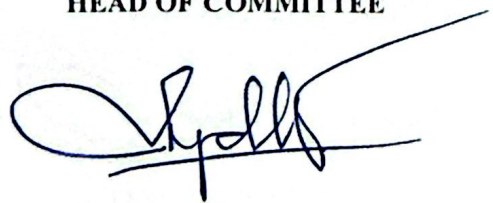
