### **3. Supervising the Board of Management by the Board of Directors:**

The Company's Board of Directors (BOD) has closely adhered to the Charter on organization and operation, as well as the regulations and rules of the Vietnam National Coal - Mineral Industries Group (Vinacomin) and of the Company, in performing corporate governance and supervising the Executive Board.

In the first half of 2025, the BOD successfully organized the Extraordinary General Meeting of Shareholders on January 9, 2025 to elect additional members to the Board of Directors, and the Annual General Meeting of Shareholders on April 25, 2025 in accordance with legal regulations. The BOD held 13 meetings, issued 13 Resolutions and 26 Decisions to enhance the Company's management across various areas such as investment and construction management, materials management, and business and production planning;

The BOD supervised and directed the General Director to review and revise five internal management regulations, (*Regulation on salary and income management; Regulation on training and professional development for staff and workers; Regulation on legal affairs operations; Regulation on emulation and commendation; Regulation on occupational health and safety management at Ha Tu Coal JSC – Vinacomin*).

The Company strictly followed the Charter and internal regulations of Vinacomin in its corporate governance. Additionally, the BOD continued to direct the Company to strengthen its management and operations in line with the production and business strategies, orientations, and plans assigned by Vinacomin, ensuring compliance with Vinacomin's unified management system and operational discipline;

The Company fully and honestly submitted all required reports on business and production performance, monitoring reports, and reports of the capital representative of Vinacomin at the Company, in accordance with Vinacomin's prescribed deadlines.

Through its supervision activities, the BOD assessed that the Executive Board had seriously complied with the Resolutions of the General Meeting of Shareholders, the Resolutions and Decisions of the BOD, the regulations and policies of Vinacomin and the Company, as well as applicable legal provisions. During the execution of its tasks, the Executive Board submitted proposals to the BOD to restructure the organizational model, reorganize the workforce, and amend internal regulations to better suit practical conditions and current legal requirements.

In the first half of 2025, the Company's Board of Supervisors held two meetings. The first meeting was conducted on March 1, 2025 to agree on the contents of the Board of Supervisors's report to be submitted to the 2025 Annual General Meeting of Shareholders and to review the performance of its members. Subsequent meetings were held in conjunction with the supervision period of the Company's management activities, focusing on finalizing the supervisory minutes for the second quarter of 2025, reviewing the Company's operations for the first half of 2024, and preparing the supervisory plan for the third quarter of 2025. All members of the Board of Supervisors fully attended the meetings.

## **3. Supervising Board of Directors, Board of Management and shareholders by Board of Supervisors.**

### **3.1 Monitoring activities:**

Based on the provisions of the Law on Enterprises and the Company's Charter regarding the functions, powers, and responsibilities of the Board of Directors and the Executive Board, the Board of Supervisors has monitored and assessed as follows:

- The convening and organization of the Annual General Meeting of Shareholders were carried out in accordance with the law, and information disclosure was conducted in a timely manner;

- The convening and organization of meetings of the Board of Directors complied with regulations. The contents of the meetings and the resolutions issued by the Board of Directors focused on business and production activities, ensuring timeliness, practicality, and high efficiency.

- The implementation of new legal regulations was taken seriously: The Board of Directors and the Executive Board strictly complied with the provisions of the Law on Enterprises, the Law on Securities, and the Labor Code applicable to joint stock companies. Regulations on finance and accounting were also strictly followed;

- The working relationship between the Board of Supervisors and the Board of Directors was carried out properly, in the spirit of objectivity, transparency, and mutual respect. Each party demonstrated a strong sense of responsibility before the General Meeting of Shareholders in accordance with their respective functions and powers.

### **3.2 The Board of Supervisors carried out its duties to inspect the reasonableness, legality, truthfulness, and prudence in the management and operation of business activities, as well as in accounting, statistics, and the preparation of financial statements by the Board of Directors and the Executive Board:**

- The reasonableness, legality, truthfulness, and prudence in the management and operation of business activities by the Board of Directors and the implementation by the Executive Board were ensured in a serious manner. Decisions were made with a high degree of consensus, closely aligned with actual business conditions, and in compliance with the law. All matters were handled openly, transparently, and honestly. In particular,



prudence was emphasized - every decision was based on thorough analysis, consideration, and risk anticipation to minimize potential losses to the Company.

- The Board of Supervisors monitored and assessed the reasonableness, legality, truthfulness, and prudence in accounting, statistics, and the preparation of financial statements as follows: The accounting and statistical work was conducted fully and honestly. Data was reasonable, lawful, and in accordance with legal regulations. Financial statements, balance sheets, income statements, and cash flow statements were prepared in compliance with regulations, ensuring objectivity and truthfulness, reflecting the actual business and production performance of the Company. The Board of Supervisors reviewed these reports both before and after the audit and concluded that the financial data and the content of the financial statements fully met the criteria of reasonableness, legality, truthfulness, and prudence in the accounting and reporting process.

- The Board of Supervisors also inspected compliance with legal regulations on taxation, salary and bonus policies, payment of social insurance, health insurance, and unemployment insurance for employees, as well as the distribution of dividends to shareholders. All were found to be implemented fully and in a timely manner.

#### **4. Coordination between the Board of Supervisors and the activities of the Board of Directors, the Executive Board, and other managers.**

The coordination among the Board of Directors, the Executive Board, and the Board of Supervisors was carried out regularly and effectively.
