The supervision of the Board of Directors is carried out regularly, promptly providing policies and directions to remove difficulties and shortcomings in production and business activities to fulfill the task of ensuring transparency, accountability, responsibility and fairness.

- Directing strongly in investment, capital mobilization, implementing the capital increase plan to ensure capital sources for implementing the Company's major projects, regularly reviewing and adjusting business mechanisms, closely following market demand according to core industries, adjusting organizational structure in accordance with the Company's investment and business plan;
- Directing the implementation of a synchronous cost reduction plan, restructuring the organizational structure and personnel of BCG Energy JSC and core member companies to streamline the apparatus, improve the working efficiency of staff in accordance with the general financial crisis situation;

During the first six months of 2025, the Board of Supervisors (BOS) will monitor the activities of the Board of Directors (BOD) and the Board of Management (BOM), ensuring transparency, compliance with the law and optimizing operational efficiency. Monitoring activities will be carried out in the following key areas:

- The Supervisory Board monitors compliance with the implementation of the Resolutions of the Executive Board and monitors the progress of implementing the Resolutions of the General Meeting of Shareholders (GMS), ensuring that decisions are implemented promptly, fully and in accordance with the direction approved by the GMS.
- The Board of Supervisors monitors the financial situation and capital mobilization, periodically reviews and inspects the Financial Reports and Management Reports to ensure that the figures reflect honestly, reasonably, comply with accounting standards and legal regulations, and closely monitors the Auditor's exceptional opinions to take appropriate actions.

- Monitor the process of capital mobilization and use for key projects, especially loans from international financial institutions and large investors. Provide recommendations to improve capital efficiency, control costs and optimize financial structure.
- Monitor financial accounting, legal, information disclosure and risk management activities to promptly detect and prevent potential risks.
- Monitor investments in waste-to-energy and renewable energy projects, ensuring efficiency and consistency with the company's long-term development strategy.

d. Monitoring Transactions with Related Parties:

- The Board of Supervisors shall check and compare accounting data and audited financial statements on transactions with subsidiaries, joint ventures, associates and individuals and organizations with special relationships according to current laws and regulations.
- Ensure transactions are carried out transparently, without conflicts of interest and without causing damage to shareholders.
- Large or high-risk transactions are closely monitored and approved by the Board of Directors or the General Meeting of Shareholders according to their authority, with clear and regular reports.
