Pursuant to Circular No. 96/2020/TT-BTC issued by the Ministry of Finance on November 16, 2020, providing guidance on information disclosure in the securities market as specified in Section 4, Article 14:

*"4. When disclosing the financial reports mentioned in Clauses 1, 2, and 3 of this Article, listed companies and large-scale public companies must provide an explanation of the causes in the following cases:*

*a) Net profit after corporate income tax in the income statement of the reporting period changes by 10% or more, compared to the report of the same period of the previous year;"*

Based on the interim consolidated financial statements 2025 of FPT Telecom Joint Stock Company which has been audited, we hereby explain the reasons for the cumulative profit after tax in the report which increases by 19% compared to the same period in 2024 as follows:

In 2025, the Company continued to enhance the quality of its transmission and customer care services while implementing various measures to boost sales, reduce costs, and improve labor productivity, optimize financial operations... As a result, the cumulative revenue for the first six months of 2025 increased by 13%, and the cumulative after-tax profit rose by 19% compared to the same period in 2024.
