- 1. Profit after tax in the statement of profit or loss for the reporting period has variated by 10% or more compared to the same period in the previous year;**
- 2. Profit after tax for the reporting period varies by at least 5% before and after auditing, shifting from a loss to a profit or vice versa:**
 - For the Reviewed Semi-Annual Financial Statements for 2024, the company's profit after tax was -2.021.134.390 VND.
 - For the Reviewed Semi-Annual Financial Statements for 2025, the Company's profit after corporation income tax is -1.363.329.534 VND. Compared to the same period last year, the Company's net profit increased by 32,55%.

Reason:

- In the first six months of 2025, administrative expenses increased and the Company reversed the provision for overdue uncollectible receivables, resulting in a variance in profit after tax.
