Disclosure content: Explanation of Profit After Corporate Income Tax in the Statement for *Semi-Annual of 2025*, which increased by more than 10% over the same period last year.

The after-tax profit in Semi-Annual of 2025 Financial Statements of Haiphong Electricity Water Machine Assembly Joint Stock Company reached **VND 22,572,906,066**, an increase of **VND 2,438,635,818** compared to the same period in 2024, equivalent to an **increase of 12%**.

The increase in after-tax profit is mainly attributed to the following reasons:

- **Revenue** increased by **VND 59,775,858,773**, equivalent to a **13.6%** increase compared to the same period last year.
- **Administrative expenses** decreased by **VND 1,179,021,146**, equivalent to an **11%** decrease compared to the same period last year.

Aside from the reasons mentioned above, the Company confirms that there is no other information materially affecting the financial statements for *Semi-Annual of 2025*.
