Profit after tax decreased by 50.18% over the same period mainly due to:

- Revenue from sales and service provision decreased by 19.21%;
- Profit/Loss in associates and joint ventures decreased by 92.42% due to a decrease in profit after tax of joint ventures and associates compared to the same period last year, specifically:

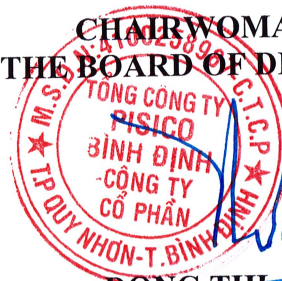
