**MAIN CONTENTS OF THE CONTRACT**  
*(Attached to Resolution No. 27/NQ - HĐQT dated 02/12/2025).*

1. Subject of the Contract: PetroVietnam Coating Joint Stock Company entered into the Contract for “Field Joint Coating Services – Block B – O Mon Pipeline Project (PC1)” with Thien Nam Offshore Services Joint Stock Company.

2. Construction progress: 90 days from the date of signing the contract.

3. Contract Value: **54.742925,520 VND** (*Fifty-four billion, seven hundred forty-two million, nine hundred twenty-five thousand, five hundred twenty dong*), VAT included, including:

- Total contract value: **42.989.674.320VND** (including 8% VAT).

- Contract value part according to fixed unit price: **11.753.251.200VND** (including 8% VAT).

4. Payment Term:

+ Advance Payment: PARTY A shall advance PARTY B 10% of the total contract value (before VAT) within 15 days after PARTY A receives valid documents.

+ First Payment: PARTY A shall pay PARTY B 35% of the total contract value after Party B mobilizes personnel, equipment and materials to assemble on TOS Ha Long ship (first payment) within 45 days.

+ Second Payment: Party A shall pay Party B 35% of the lump - sum contract value within 45 days after Party B mobilizes personnel, equipment, and materials in accordance with the pipe-laying plan (Batch 2), and upon Party A's receipt of valid documentation.

+ Third Payment and Final Settlement: PARTY A shall pay up to 100% of the total contract value and the fixed unit price contract part to PARTY B within 45 days after completing the construction work and completion documents.

5. The law applicable to dispute resolution is the Law of the Socialist Republic of Vietnam. Dispute resolution will be resolved by arbitration at the Vietnam International Arbitration Center (VIAC) located at the Vietnam Chamber of Commerce and Industry (VCCI) according to the VIAC arbitration rules and current laws of Vietnam.
